

**CERTIFICATE OF LOCATION**  
(Nevada-Lode)

The undersigned Houston Oil & Minerals Corporation, whose address is 222 Milwaukee Street, Suite 408, Denver, Colorado 80206, hereby certifies that it has located the Mayle #3 lode mining claim, more particularly described below. The date of location is the 25th day of March, 1980.

The number of linear feet claimed in length along the course of the vein, each way from the point of discovery, is 1450 feet in a northerly direction and 50 feet in a westerly direction, together with 300 feet on each side of the center of the vein.
