

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN

The undersigned hereby certify that they have located the
AA# 519 Lode Mining Claim in SE 1/4 Sec. 14 and
NE 1/4 Sec. 23

49 Township 36 North, Range
49 East, Mount Diablo Base and Meridian, in Eureka County, in
the State of Nevada on the 2nd day of April, 1980.

The claim is 1500 feet long and 600 feet wide, and 1470 feet
is claimed in a northerly direction and 30 feet is claimed in
a southerly direction from the location monument, at which the Notice
of Location is posted, lengthwise of the claim, together with 300
feet in width on side of the center of the claim. The general course
of the lode deposit and premises is northerly and southerly.

The location and number of each corner of this claim is shown
on the claim map that is filed herewith. On the ground, each corner
of the claim is marked with its appropriate symbol by scribing the
wood. Each corner post is a 4" dia. x 4 1/2' wooden post.

The claim boundaries are more specifically described as follows:
beginning at the location monument which is situated approximately
9855 feet southeasterly from the northwest corner of Section
22, Township 36 North, Range 49 East, thence southerly 30 feet
to the center of the south end line, point of origin, thence westerly
300 feet to a corner post marked "1 of AA# 519", thence northerly
750 feet to a side center post marked "2 of AA# 519", thence northerly
750 feet to a corner post marked "3 of AA# 519", thence easterly 600
feet to a corner post marked "4 of AA# 519", thence southerly 750 feet
to a side center post marked "5 of AA# 519", thence southerly 750 feet
to a corner post marked "6 of AA# 519", thence westerly 300 feet to
the center of the south end line, point of origin.

AA# _____ on the north, AA# 520 on the east, AA# _____ on
the south, AA# 518 on the west.

The monumentation and marking of the corners was completed by the
2nd day of April, 1980.

This claim is in the unknown Mining District.
