To the Sheriff of Eureka County,  
GREETINGS:

WHEREAS, on the 14th day of April, 1980, HANEY SEED  
COMPANY, INC., an Idaho Corporation, Plaintiff, recovered a  
judgment in the District Court of the Fifth Judicial District  
of the State of Idaho, in and for the County of Jerome against  
DALTON WILSON, Defendant, for the sum of SEVEN THOUSAND TWO HUNDRED  
SIXTY-THREE DOLLARS, (\$7,263.00), together with costs of suit in  
the amount of ONE HUNDRED TEN DOLLARS (\$110.00), at the date of  
said judgment, and an attorney fee in the amount of TWO THOUSAND  
FIVE HUNDRED DOLLARS (\$2,500.00); and

WHEREAS, said foreign judgment was filed, pursuant to  
N.R.S. 17.330 et seq., commonly known as the Uniform Enforcement  
of Foreign Judgments Act as Case No. 2995, in the Third Judicial  
District Court of the State of Nevada, in and for the County of  
Eureka; and

WHEREAS, the judgment rule in the action in which said

1 judgment is now entered is filed in the office of the Clerk of  
2 said Court in the County of Eureka, and the said Judgment was  
3 docketed in said Clerk's Office, and in the said Eureka County on  
4 the 28th day of April, 1980. Payments and partial satisfaction  
5 in the amount of \$ None, appear of record as a credit.

6 And the sum of NINE THOUSAND EIGHT HUNDRED SEVENTY-THREE  
7 DOLLARS (\$9,873.00), is now actually due on said judgment, to which  
8 must be added the commissions and costs of the officer executing  
9 this writ.

10 NOW, THEREFORE, SHERIFF OF EUREKA COUNTY, YOU ARE  
11 HEREBY COMMANDED to satisfy such judgment with interest and costs  
12 as provided by law out of the personal property of such judgment  
13 debtor except that for any pay period Seventy-five (75) percent of  
14 the disposable earnings of such debtor during such period, or the  
15 amount by which his disposable earnings for such period exceeds  
16 thirty (30) times the minimum hourly wage prescribed by Section 6  
17 (a) (1) the Federal Fair Labor Standards Act of 1938, and in effect  
18 at the time of the earnings are payable, whichever is greater is  
19 exempt from any levy of execution pursuant to this Writ and if  
20 sufficient personal property cannot be found, then out of the real  
21 property belonging to such debtor in the aforesaid county and make  
22 return to this Writ within not less than ten (10) days, nor more  
23 than sixty (60) days endorsed thereon with what you have done.

25 Third Judicial District of the State of Nevada, at the Courthouse
