

# Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 1480 feet is claimed in a north direction and 20 feet in a south direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the north to the south.

Corner No. 5 is a 4" x 4" x 4 1/2" FL wooden post marked N.E. cor STOCKTON #39  
Corner No. 6 is a 4" x 4" x 4 1/2" FL wooden post marked N.W. cor STOCKTON #39

The monumentation and marking of the corners was completed by the 12<sup>th</sup> day of May, 1980

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the \_\_\_\_\_ County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
