COUNTIES OF EUREKA AND LANDER, STATE OF NEVADA

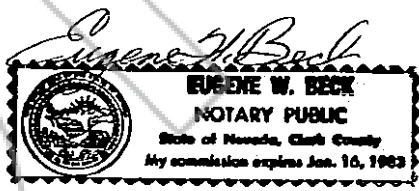
