

DECLARATION OF HOMESTEAD

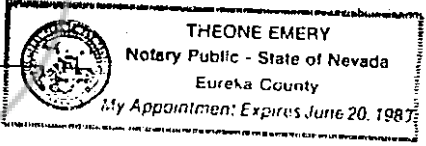
