

**CERTIFICATE OF LOCATION  
LODE MINING CLAIM**

KNOW ALL MEN BY THESE PRESENTS that the undersigned locators, having complied with all of the requirements of law and local rules and customs, have claimed and claim by right of discovery and location, a lode mining claim situated in the Mt. Hope Mining District, County of Eureka, State of Nevada, and hereby certify that:

(c) Said mining claim was located on May 22, 1980, in about Sections 32, Township 23 North, Range 52 East, M.D.B. & M., and is bounded and described as follows:

Commencing at the Southeast Corner which bears 1490 feet Southerly and 300 feet Easterly from the location monument; thence Westerly 600 feet to the SW Corner; thence Northerly 1500 feet to the NW Corner; thence Easterly 600 feet to the NE Corner; thence Southerly 1500 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 3320 feet in a N. 46° 10' E. direction from the Southeast Corner of Section 31, Township 23 North, Range 52 East, M.D.B. & M. This lode claim, Tt No. 4, is Northerly of Tt No. 22, Southerly of Tt No. 3, Easterly of Tt No. 6, and Westerly of Tt No. 2, lode claims.

(d) The undersigned claim 1500 feet, linear and horizontal in measurement, along the course of the vein, together with 300 feet in width on each side of the center of the vein, 10 feet of said lode running Northerly from the point of discovery (designated by the location monument). The general course of the lode as near as may be presently determined, is Northerly and Southerly.

(e) Since the date of said location and prior to the date of this certificate, the undersigned caused work to be performed for location upon said mining claim consisting of maps as provided by NRS 517.040.

(f) The location monument, each corner and side line center marker is in each instance represented by a post at least 4 inches in diameter by 4½ feet in length and set 1 foot in the ground, the respective corner posts being marked as follows: SE Corner, Tt No. 4; SW Corner, Tt No. 4; NW Corner, Tt No. 4; and NE Corner, Tt No. 4.
