## CERTIFICATE OF LOCATION LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS that the undersigned locators, having complied with all of the requirements of law and local rules and customs, have claimed and claim by right of discovery and location, a lode mining claim situated in the Mt. Commencing at the Southeast Corner which bears 10 feet Southerly and 300 feet Easterly from the location monument; thence Westerly 600 feet to the SW Corner; thence Northerly 1500 feet to the NW Corner; thence Easterly 600 feet to the NE Corner; thence Southerly 1500 feet to the SE Corner, the point of beginning.
