CERTIFICATE OF LOCATION LODE MINING CLAIM

Commencing at the Southeast Corner which bears 1490 feet Southerly and 300 feet Easterly from the location monument; thence Westerly 600 feet to the SW Corner; thence Northerly 1500 feet to the NW Corner; thence Easterly 600 feet to the NE Corner; thence Southerly 1500 feet to the SE Corner, the point of beginning.
