(c) Said mining claim was located on June 10, 1980, in about Sections 5, 6, 31, & 32, Townships 22 & 23 North, Range 52 East, M.D.B.& M., and is bounded and described as follows:

Commencing at the Southeast Corner which bears 300 feet Southerly and 10 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 740 feet in a N. 81° 40' E. direction from the SE Corner of Section 31, Township 23 North, Range 52 East, M.D.B.& M.
