such that 1310 feet is claimed in a NORTH direction
and 10 feet in a SOUTH direction from the discov-
ery monument, at which the Notice of Location is posted, lengthwise of
the claim, together with 300 feet in width on each side of
the discovery monument and centerline of the claim. The general course
of the lode deposit and premises is from the NORTH to the
SOUTH direction.
