IN WITNESS WHEREOF, the Seller has executed this Bill of Sale the 14<sup>th</sup> day of July, 1980.

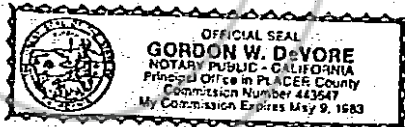
