

DEED OF TRUST

3 THIS DEED OF TRUST, made and entered into this 22 day of  
4 July, 1980, by and between PETER J. GOICOECHEA and GLADY  
5 GOICOECHEA, husband and wife of Eureka, Nevada, P.O. Box 97, here-  
6 inafter called "Grantor", and FIRST NATIONAL BANK OF NEVADA,  
7 EUREKA BRANCH, Eureka, Nevada, "Trustee" and CIRIACO and ROSE  
8 HERRERA, husband and wife of Reno, Nevada, as joint tenants with  
9 right of survivorship, hereinafter called "Beneficiaries".

10 WHEREAS, the Grantor is indebted to the Beneficiaries in the  
11 sum of EIGHT THOUSAND DOLLARS, (\$8000.00), lawful money of the  
12 United States of America, and has agreed to pay the same according  
13 to the tenor and terms of a certain Promissory Note bearing even  
14 date and made, executed and delivered by the Grantor to the said  
15 Beneficiaries, a copy of which Note is attached hereto as Exhibit  
16 "A" and made a part hereof.

17 NOW, THEREFORE, the said Grantor, for the purpose of securing  
18 the payment of the said Promissory Note, and the principal and  
19 interest, and all other amounts set forth, or therein provided to  
20 be paid, and also the payment of all other moneys herein agreed  
21 or provided to be paid by the said Grantor, if such payments are  
22 made under the provisions of this instrument, with interest in  
23 each case, hereby grants, bargains, sells, conveys and confirms  
24 unto the said Trustee all the right, title, estate, interest,  
25 homestead or other claim or demand, as well in law as in equity,  
26 which the said Grantor now has or may hereafter acquire of, in or  
27 to the property, improvements and appurtenances, situate in the  
28 Town of Eureka, County of Eureka, State of Nevada, and more part-  
29 icularly described as follows:

3 assigns for the uses and purposes herein mentioned.

4 The following covenants of NRS 107.030 are hereby adopted and  
5 made a part of this Deed of Trust: Nos. 1; 2 (\$none), 3;  
6 4 (6%); 5; 6; 7 (reasonable), 8; and 9.

7 Said Grantor, in consideration of the premises, hereby coven-  
8 ants and agrees that neither the acceptance nor existence, now or  
9 hereafter, or other security for the indebtedness secured hereby,  
10 or the release thereof, shall operate as a waiver of the security  
11 of this Deed of Trust, nor shall this Deed of Trust nor its satis-  
12 faction nor a reconveyance made thereunder operate as a waiver of  
13 any such other security now held or hereafter acquired.

14 This Deed of Trust shall inure to the benefit of and be binding  
15 upon the Grantor as indicated in the first paragraph of this Deed  
16 of Trust, and their respective heirs, executors, administrators  
17 and assigns accordingly.

NOTE SECURED BY DEED OF TRUST

\$8000.00, Eureka, Nevada, July 22nd, 1980, PETER J. GOICOECHEA and GLADY GOICOECHEA, after date, for value received, undersigned promise to pay to CIRIACO HERRERA and ROSE HERRERA, or order, at Reno, Nevada, the sum of EIGHT THOUSAND DOLLARS, (\$8000.00), with interest at six (6%) percent per annum, payable as follows: The sum of ONE THOUSAND DOLLARS, (\$1000.00), plus interest at the rate of six percent (6%) per annum payable on the 22nd day of July, 1981, and a like sum of ONE THOUSAND DOLLARS, (\$1000.00), plus interest as aforesaid on the 22nd day of July of each and every calendar year thereafter, until the entire sum of EIGHT THOUSAND DOLLARS, (\$8000.00), plus interest has been fully paid.

Should default be made in payment of any principal and interest or in the performance of any obligation contained in the Deed of Trust by which this note is secured, the whole sum of principal and interest shall become immediately due at the option of the holder hereof. Principal and interest payable in lawful money of the United States. If action be instituted in any Court to enforce any obligation secured by such Deed of Trust, undersigned promise to pay such sum as the Court may fix as attorney's fees in said action.
