Dear Mr. Gibellini:

My report on the geochemistry of three drillholes from "Ridge 7129" probably won't be available for another month or two, but in response to your request of 4 August on the telephone, I can give you the following information about the time and effort involved in the study.

A total of 103 samples of drill cuttings from your mining claims were analyzed by emission spectroscopic methods for 43 major and trace elements by the U.S. Geological Survey. A computer program was developed and used to display the data graphically. About 20 of the samples also were analyzed mineralogically using X-ray diffraction techniques. My participation in these projects, and in the preparation of the forthcoming Open-File report took an estimated 6-8 man-months.

It is not possible for me to give you an estimate of the total cost of this work, but you may be able to determine the approximate investment by comparing this work with that of private laboratories and consultants.

Thank you again for your permission to release the report. If you have any information on the new "breccia" deposit being evaluated now, I would much appreciate seeing it (if circumstances permit).
