

CERTIFICATE OF LOCATION
LODE CLAIM

The undersigned, hereby certify that They have located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the Virgin Formation. The name of this claim is NANCY # 152.

The general course of said lode or vein, as near as it may be described, is EAST and WEST.

The Northeast corner is marked by a 4" dia. post 4 1/2 feet high inscribed NE corner of NANCY # 152, the Northwest corner is marked by a 4" dia. post 4 1/2 feet high inscribed NW corner of NANCY # 152, the Southeast corner is marked by a 4" dia. post 4 1/2 feet high inscribed SE corner of NANCY # 152, the Southwest corner is marked by a 4" dia. post 4 1/2 feet high inscribed SW corner of NANCY # 152. There is a 4" dia. post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since 6/5/80. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
