

76430 CERTIFICATE OF LOCATION
LODE CLAIM

The undersigned, hereby certifies that he has located a mining claim in the Unnamed Mining District, County of Eureka, State of Nevada, on a vein or lode known as the Vinini Formation. The name of this claim is LYNDALL # 24.
