

EXHIBIT A

The Limited Partner, Mary Morris Leighton, will contribute to the Partnership a 13.200% undivided interest in the Eureka Properties, an 11.800% undivided interest in the Special Eureka Properties, and a 16.500% undivided interest in the Other Properties. The interest in the Eureka Properties and the Special Eureka Properties contributed by the Limited Partner has an aggregate agreed minimum value of \$29,160. The interest in the Other Properties contributed by the Limited Partner has an agreed minimum value of \$24,299. Thus, together with the \$18,495 in cash contributed by the Limited Partner, the agreed minimum value of the entire capital contribution by the Limited Partner is \$71,954.
