

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Bob #15 Lode Mining Claim in SE 1/4 of Section 6, Township 29N, Range 49E in the Beowawe Mining District, in Eureka County, in the State of Nevada, on the 16th day of July, 1980.

The general course of the lode deposit and premises is from the North to the South.
