

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Bob # 56 Lode Mining Claim in NE 1/4 NW 1/4, Section 12, Township 29N, Range 48E in the Beowawe Mining District, in Eureka County, in the State of Nevada, on the 21st day of July, 1980.
