

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Bob #68, 49E Lode Mining Claim in SW 1/4, Section 32, Township 29N, Range 49E in the Beowawe Mining District, in Eureka County, in the State of Nevada, on the 2nd day of August, 1980.

The general course of the lode deposit and premises is from the North to the South. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Scribed Metal Tag.
