

CERTIFICATE OF LOCATION LODE CLAIM

The undersigned, hereby certifies that he has located a mining claim in the Unnamed Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the Vinni Formation. The name of this claim is Lyndall # 71.

The general course of said lode or vein, as near as it may be described, is North and South.

The locator Claims 1480 feet in a North direction and 20 feet in a South direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The Northeast corner is marked by a 4" $\frac{1}{2}$ x $\frac{1}{2}$ post 4 1/2 feet high inscribed NE corner of Lyndall # 71, the Northwest corner is marked by a 4" $\frac{1}{2}$ x $\frac{1}{2}$ post 4 1/2 feet high inscribed NW corner of Lyndall # 71, the Southeast corner is marked by a 4" $\frac{1}{2}$ x $\frac{1}{2}$ post 4 1/2 feet high inscribed SE corner of Lyndall # 71, the Southwest corner is marked by a 4" $\frac{1}{2}$ x $\frac{1}{2}$ post 4 1/2 feet high inscribed SW corner of Lyndall # 71. There is a 4" $\frac{1}{2}$ x $\frac{1}{2}$ post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since July 3, 1980. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
