**LODE CLAIM**

The undersigned, hereby certify that They have located a mining claim in the Unknown Mining District, County of Eureka, State of Nevada, on a vein or lode known as the Freedom Lode. The name of this claim is FREEDOM #5.

The general course of said lode or vein, as near as it may be described, is NE - SW and dips NW.

The locator Claim 1485 feet in a N 50° E direction and 15 feet in a S 50° W direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The location and description of each corner with the markings thereon are as follows:

The Northeast corner is marked by a 4" dia. post 4 1/2 feet high inscribed NE corner of FREEDOM #5, the Northwest corner is marked by a 4" dia. post 4 1/2 feet high inscribed NW corner of FREEDOM #5, the Southeast corner is marked by a 4" dia. post 4 1/2 feet high inscribed SE corner of FREEDOM #5, the Southwest corner is marked by a 4" dia. post 4 1/2 feet high inscribed SW corner of FREEDOM #5. There is a 4" dia. post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since 7/24/80. The location work consisted of making a claim map as provided in NRS 517.0-10. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
