The general course of the lode deposit and premises is from the northly to the southerly.

Corner No. 5 is a 4" x 4" x 4 1/2 FT wooden post marked S.E. corner (CUB #1)

Corner No. 6 is a 4" x 4" x 4 1/2 FT wooden post marked S.W. corner (CUB #1)

The monumentation and marking of the corners was completed by the 29th day of Sept, 1980.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
