(5) Deep geophysics and other work by Inspiration Development Co. Said geophysics, restricted to pediment area




- (7) Maintenance of four miles of roads, trails and drill-site access;
- (8) Maintenance of full-time, year-round camp;
- (9) Sample-drilling, (up to 5 feet), various outcrops;
- (10) Re-monumenting;
- (11) Cost of supplies, including chemicals, gas & oil, forms, parts, etc.;
- (12) Lease and repair of equipment; and
- (13) On-going sampling, mapping and other work by major exploration firm.
