

CERTIFICATE OF LOCATION
LODE CLAIM

The undersigned, hereby certify that they have located a mining claim in the unnamed Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the Virgin Formation. The name of this claim is Lyndall #85.

The general course of said lode or vein, as near as it may be described, is NORTH and South.

The name of the locator is All Minerals Corporation, 5510 So. 300 West, P.O. Box 7680, Murray, Utah 84107 by Ed BALOGH Agent of the same address.

The said claim was located on the 7th day of August 1980, and is described in respect to, situated Approximately 14090 ft E and 6260 ft North from Sec Corner 24 T23N, R49E MDB&M on surveyed and/or unsurveyed lands which when surveyed would probably include portions of the following:

The locator Claims 5 20 feet in a NORTH direction and 1480 feet in a South direction along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The location and description of each corner with the markings thereon are as follows:

The Northeast corner is marked by a 4" dia PVC post 4 1/2 feet high inscribed NE corner of Lyndall #85, the Northwest corner is marked by a 4" dia PVC post 4 1/2 feet high inscribed NW corner of Lyndall #85, the Southeast corner is marked by a 4" dia PVC post 4 1/2 feet high inscribed SE corner of Lyndall #85, the Southwest corner is marked by a 4" dia PVC post 4 1/2 feet high inscribed SW corner of Lyndall #85. There is a 4" dia PVC post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since 8/17/80. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
