described lands, subject to and in accordance with the terms and provisions of the hereinabove referred to lease.It is agreed that the amount of the annual Delay Rental which may be hereafter paid under the terms of said above referred to lease as  
hereby amended shall be Two Thousand Four Hundred Forty Two and 60/100 Dollars (\$ 2,442.60).The undersigned do hereby warrant and agree to defend the title to the lands hereinabove described, and it is specifically agreed and under-  
stood that the terms and conditions of said original oil, gas and mineral lease are not changed or affected, but are hereby acknowledged and em-  
bodied and made a part hereof as fully as if written herein, and said original lease is hereby ratified and confirmed and declared to be in full  
force and effect.The undersigned release and waive all rights of homestead and agree that this instrument shall be binding upon them and their heirs, suc-
