

SUPPLEMENTAL OIL, GAS AND MINERAL LEASE

containing 407.10 acres, more or less, Amoco Production Company being now the legal owner and holder of said oil, gas and mineral lease and all rights thereunder; and

WHEREAS, it is the desire of the undersigned to amend and to ratify and affirm said lease so as to include within its terms and provisions all of the right, title, interest, and estate of the undersigned in and to the above described lands.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS: THAT for and in consideration of the sum of Ten or MORE Dollars (\$ 10.00 or more), cash in hand paid to the undersigned, receipt of which is hereby acknowledged, and of the covenants and agreements set out in said original lease, all of which are acknowledged and included herein, the undersigned do by these presents grant, demise, lease and let unto the said AMOCO Production Company

for the purposes set out in the aforementioned lease all of their right, title, interest and estate in and to the above described lands, subject to and in accordance with the terms and provisions of the hereinabove referred to lease.

It is agreed that the amount of the annual Delay Rental which may be hereafter paid under the terms of said above referred to lease as hereby amended shall be Two Thousand Four Hundred Forty Two and 60/100 Dollars (\$ 2,442.60).

The undersigned do hereby warrant and agree to defend the title to the lands hereinabove described, and it is specifically agreed and understood that the terms and conditions of said original oil, gas and mineral lease are not changed or affected, but are hereby acknowledged and embodied and made a part hereof as fully as if written herein, and said original lease is hereby ratified and confirmed and declared to be in full force and effect.

The undersigned release and waive all rights of homestead and agree that this instrument shall be binding upon them and their heirs, successors, and assigns.
