THAT the undersigned Nuclear Power & Energy Co., who is a citizen of the United States of America by birth hereby claims the land described herein as a lode mining claim, pursuant to the laws of the United States and the State of Nevada.

THAT on the 25 day of September, 1980, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, within the limits of this claim as hereinafter established.

THAT the name of this claim is CEDAR # 44

THAT the undersigned claims, by right of discovery and location, 1500 feet, linear and horizontal measurement, on this lode, 1490 feet running N45°E from the discovery, and 10 feet running S45°W from the discovery, together with 300 feet on each side of the discovery monument of this lode.

THAT the exterior boundaries of this claim are distinctly marked by six 4" diameter posts, marked on the side or sides which face in toward the claim, and are located one at each corner and one at each side center,

THAT the extent of the claim is as follows:  
Beginning at Corner No. 1, the NW Corner of this claim,  
Thence 750' S45°W to Corner No. 2, the WEST Side Center,  
Thence 750' S45°W to Corner No. 3, the SW Corner,  
Thence 600' S45°E to Corner No. 4, the SE Corner,  
Thence 750' N45°E to Corner No. 5, the EAST Side Center,  
Thence 750' N45°E to Corner No. 6, the NE Corner,  
Thence 600' N45°W to Corner No. 1, the point of beginning.

TIE: Corner No. 3 of this claim bears 10,831.3' EAST & 2620' S45°W from the NW Corner of Section 33 Township 24N, Range 48E, Mount Diablo P.M.

LOCATION: This claim is located in the NE Quarter of Section 34, Township 24N, Range 48E, Mount Diablo P.M., Eureka County, Nevada.

THAT the location work for this claim consists of preparing a map of this claim which sets forth the position of the claim boundary monuments in relation to each other as provided in NRS 517.040.

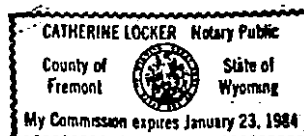
