The undersigned hereby certifies (certify) that he (she, they) has (have) located the U.A.T.C. #13 Lode Mining Claim in the following quarter section(s): 31, Township 27N, Range S3E, M.D.B.&M., in the 16000 Mining District, in Esmeralda County, in the State of Nevada, on the 30 day of Dec, 1980.

The Claim is 1500 feet long and 1000 feet wide, such that 750 feet is claimed in a Southwesterly direction and 750 feet in a Northerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 500 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the Northerly to the Southwesterly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 30 day of Dec, 1980.
