The Claim is 1500 feet long and 1000 feet wide, such that 750 feet is claimed in a Southerly direction and 750 feet in a Northerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the Northerly to the Southerly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 21 day of Dec, 1980.
