It is suggested that this form be used as a mill site Notice of Location, with the word Certificate crossed out and Notice written in.

**Note 3:** "Every person who willfully and knowingly makes a false material statement on the location certificate or on any map required by this chapter shall be guilty of a felony, and upon conviction thereof shall be imprisoned in the state prison for not less than 3 years nor more than 10 years." NRS 517.300, Subsection 2.

**Note 4:** The claim map of this claim is filed in the Eureka County Recorder's Office as Document No. 78386 (may be filled in by locator).
