


STATE OF NEVADA  
CERTIFICATE OF MINING LOCATION  
LODE CLAIM ON PUBLIC DOMAIN

NOTICE IS HEREBY GIVEN that the Lake No. 120  
lode mining claim has been located by AMERICAN SELCO INC.  
a New York corporation, whose address is 90 West Grove Street,  
Suite 100, Reno, Nevada 89509. The general course of this claim  
is North/South. This claim is 1500 feet in length  
along the course of the claim, being 20 feet from the point  
of discovery in a North direction to the North end  
line of this claim, and 1480 feet in a South  
direction to the South end line of the claim. This claim is  
600 feet in width, being 300 feet in width on each side of the  
center line of the claim.

This claim is located within the NE & SE Quarter  
of Section 34, Township 19 North, Range 52  
East, Mount Diablo Base and Meridian, unknown Mining District,  
Yreka County, Nevada. The location monument of this claim is  
situated with reference to some natural object or permanent monument  
as follows: The number one corner of this claim is located approx.  
3,875 Ft. N38°20'W from claim location marker LA-2.

The claim location marker LA-2, a 3" x 6" steel pipe, is  
located approximately 18,400' N51°W from BM 7709; 14,000' N12°W from  
BM 7336; 21,000' N27½°E from Combs Peak VAMB 8631.

The corners of this claim are marked by 4"x4" posts or 4" trees  
with metal tags inscribed with the appropriate corner number as  
shown on the following sketch and the accompanying claim map.



The location work consisted of making the maps as provided in  
NRS 517.040.
