MODIFICATION OF LEASE NO. SPL-266

THIS SUPPLEMENTAL AGREEMENT, made this 15th day of July 1980, by and between SOUTHERN PACIFIC LAND COMPANY, a corporation, herein called "Lessor," and GETTY OIL COMPANY, NORTH CENTRAL OIL CORPORATION and AMOCO PRODUCTION COMPANY, hereinafter called "Lessee;"

RECITALS:

The parties hereto, or their respective predecessors in interest, entered into a lease dated July 15, 1975, which, as modified, now covers 23,695.62 acres, more or less, in the Counties of Eureka and Elko, in the State of Nevada.

It is desired to amend and modify said lease as hereinafter set forth.

AGREEMENT:

- 1. The Exhibit "B," attached and made a part hereof, is hereby substituted for the Exhibit "A," attached to said lease dated July 15, 1975, and it is agreed that, commencing as of the date hereof, the term "leased premises," as used in said lease, shall include the 17,005.29 acres, more or less, as delineated in said Exhibit "B."
- 2. Commencing July 15, 1980, Lessee shall pay to Lessor, as advance rental, Two Dollars (\$2,00) per acre (\$34,010.58) for the year commencing July 15, 1980, and annually thereafter, for the lease of said property, except such portions thereof as may be held subject to the production and well drilling provisions of said lease.
- 3. The time within which the drilling of an oil or gas well on said property shall be commenced is hereby extended to the 15th day of July, 1983.
- 4. Lessor shall have the right to enter upon and to conduct geological and geophysical explorations upon the surface of the lands included hereunder at any and all times during the life of the said lease, as amended, together with the right to locate equipment with such access as may be necessary incidental or convient in carrying out these purposes.
