

The undersigned Grantor(s) hereby grant(s) to BELL TELEPHONE COMPANY OF NEVADA, Grantee, its successors and assigns, an easement to construct and maintain (place, operate, inspect, repair, replace and remove) such underground communication facilities as Grantee may from time to time require (including ingress thereto and egress therefrom) consisting of wires, cables, conduits, manholes, handholes and aboveground markers, pedestals, terminal equipment cabinets, other associated electrical conductors and necessary fixtures and appurtenances in, under and upon that certain real property in the County of Eureka, State of Nevada described as:

Commencing at the northeast corner of said Section 2; thence South 53°29'40" West 4475.77 feet to the TRUE POINT OF BEGINNING; thence South 38°09'55" West 83.16 feet; thence South 37°58'42" West 455.24 feet; thence South 30°58'53" West 133.08 feet.

PARCEL II

That portion of the northwest one-quarter of the northwest one-quarter (NW 1/4 of NW 1/4) of Section 11, Township 34 North, Range 51 East, M.D.B.&M., more particularly described as follows: a strip of land ten (10.00) feet in width, five (5.00) feet on each side of the following described centerline:

Commencing at the northwest corner of said Section 11; thence South 89°53'00" East 157.27 feet to the TRUE POINT OF BEGINNING; thence South 24°53'53" West 34.22 feet; thence South 20°49'49" West 410.58 feet.

PARCEL III

That portion of the east one-half of the east one-half (E 1/2 of E 1/2) of Section 10, Township 34 North, Range 51 East, M.D.B.&M., more particularly described as follows: a strip of land ten (10.00) feet in width, five (5.00) feet on each side of the following described centerline:

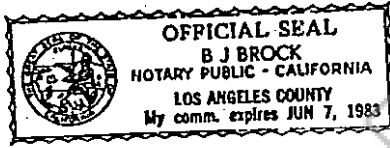
