CERTIFICATE OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the WY 84 lode mining claim in the unorganized mining district, Eureka County, in the State of Nevada, on the 16th day of January, 1981, for Chevron U.S.A., Inc., P.O. Box 4001, Golden, Colorado 80401

This claim is located in Township 31 North, Range 48 East, of the Mount Diablo Meridian in the following one quarter section(s):

SE 1/4 of SEC 8  
SW 1/4 of SEC 9

The claim is 1200 feet long and 250 feet wide and 1180 feet is claimed in a N. 89° 38' E. direction along the length of the claim and 20 feet is claimed in a S. 89° 38' W. direction along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 125 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a N. 89° 38' E. and S. 89° 38' W. direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location, and markings on each boundary or corner monument is as follows:

As erected on the ground each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monumentation and markings of the above mentioned corners on the ground was completed by the 21st of January, 1981, and the location work consisted of making a claim map as provided in NRS.517.040. Two copies of this map has been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
