## AMENDMENT OF LEASE AGREEMENT (SHORT FORM)

January 1976 (such lease being of record in the Office of the County Recorder of Eureka County, Nevada in Book 54 of Official Records at Page 574 et seq.) whereby Lessor did grant, let and lease unto Lessee for the purposes therein described certain lands situate in said County and State particularly described in such lease, such lease being hereinafter referred to as "said lease";

containing 80.00 acres of land more or less, for the term and purposes and subject to all of the other provisions of said lease as hereby amended. Lessor further agrees that said lease as hereby amended is in good standing and in full force and effect. Lessor acknowledged receipt of rental in full under said lease to January 24, 1982.

This agreement shall bind and inure to the benefit of the respective heirs, executors, administrators, successors and assigns of the parties hereto.
