

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the RC 2 Lode Mining Claim in Section 22, Township 18 N, Range 53 E in the Secret Canyon Mining District, in Eureka County, in the State of Nevada, on the 27 day of January, 1981.

The claim is 1500 feet long and 600 feet wide, and 50 feet is claimed in a North direction and 1450 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by black marking pen.

- Corner No. 1 is a 4 inch diameter white PVC plastic post

- Corner No. 5 is a 4 inch diameter white PVC plastic post
- Corner No. 6 is a 4 inch diameter white PVC plastic post

The monumentation and marking of the corners was completed by the 10<sup>th</sup> day of February, 1981.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
