AFFIDAVIT

The undersigned, being JOANN K. WILSON, as executrix and sole devisee and legatee under the will of A.K. Wilson, Jr., deceased, residing in Reno, Nevada, JOAN WILSON, W.L. WILSON and WILLIAM G. WALDECK, each residing in Grand Junction, Colorado (the "Undersigned" herein), each of lawful age and being duly sworn upon oath, make this Affidavit with respect to the following facts:

1. The Undersigned constitute all of the Grantees (or the successor in interest to the Grantees) under that certain Supplemental Royalty Deed dated December 20, 1979, from Idaho Mining Corporation, as Grantor, and A.K. Wilson, Jr., et al., as Grantees, recorded in Book 77 at Pages 362 through 367, inclusive, of the Official Records of Eureka County, Nevada.
2. The Undersigned are the Grantees in that certain Supplemental Royalty Deed dated October 30, 1980, from Idaho Mining Corporation to the Undersigned, recorded in Book 89 at Pages 245 through 249, inclusive, of the Official Records of Eureka County, Nevada.
3. JoAnn K. Wilson, as the executrix and sole legatee and devisee under the will of A.K. Wilson, Jr., deceased, has succeeded to the interest of the decedent, one of the Grantees in the Supplemental Royalty Deed described in Paragraph 1 above.
4. The Supplemental Royalty Deeds described in Paragraphs 1 and 2 above convey to the Grantees a five percent royalty on mineral substances produced from certain unpatented mining claims in the Eureka Mining District, Eureka County, Nevada. The following mining claims are listed on both such deeds referred to above:  
 HC Nos. 1 through 20, inclusive; the HC Fraction; the IM Nos. 1 through 18, inclusive; and the F Nos. 55 through 90, inclusive; are listed on both such Supplemental Royalty

Deeds. The Undersigned hereby represent, agree and affirm that it was not the intention of such Supplemental Royalty Deeds to convey a ten percent royalty interest in the claims which were described in both of the two Supplemental Royalty Deeds, but instead the Undersigned are entitled solely to a five percent royalty, on all mineral substances produced from each of the Mining Claims described in the Deeds, calculated as provided in such deeds.


