

## STATE OF NEVADA CERTIFICATE OF MINING LOCATION LODE CLAIM ON PUBLIC DOMAIN

NOTICE IS HEREBY GIVEN that the RIL No. 7
lode mining claim has been located by AMERICAN SELCO INC.
a New York corporation, whose address is 90 West Grove Street, Suite 100, Reno, Nevada 89509. The general course of this claim is Northeast & Southwest. This claim is 1500 feet in length along the course of the claim, being 10 feet from the point of discovery in a N50°E direction to the Northeast end line of this claim, and 1490 feet in a S50°W direction to the Southwest end line of the claim. This claim is 600 feet in width, being 300 feet in width on each side of the center line of the claim.
