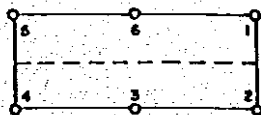
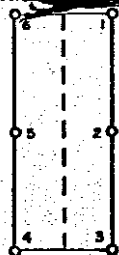

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH 839 Lode Mining Claim on this 15TH day of FEBRUARY, 19 81, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

(\*) Said Claim is located in the SE&SW (Quarter), Section(s) 28 Township 22 NORTH, Range 51 EAST, Mt. Diablo P. M., and more particularly described as follows, to-wit:

Beginning at the Northeast Corner Post Number 1,

Thence, 600 feet in a SOUTHERLY direction to Post Number 2,  
Thence, 750 feet in a WESTERLY direction to Post Number 3,  
Thence, 750 feet in a WESTERLY direction to Post Number 4,  
Thence, 600 feet in a NORTHERLY direction to Post Number 5,  
Thence, 750 feet in a EASTERLY direction to Post Number 6,

the point of beginning, and all posts being 4½' x 4" x 4" (OR A CUT TREE)
