

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH 1138 Lode Mining Claim on this 10TH day of FEBRUARY, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

(* Said Claim is located in the NE (NW)(SE)(SW) (Quarter); Section(s) 35 (36)(26)(25) Township 22 NORTH, Range 51 EAST, Mt. Diablo P. M., and more particularly described as follows, to-wit:

Beginning at the Northeast Corner Post Number 1,

- Thence, 600 feet in a SOUTHERLY direction to Post Number 2,
- Thence, 550 feet in a WESTERLY direction to Post Number 3,
- Thence, 550 feet in a WESTERLY direction to Post Number 4,

- Thence, 550 feet in a EASTERLY direction to Post Number 1,

the point of beginning, and all posts being 4 1/2" x 4" x 4" (OR A CUT TREE)

The Claim Monument on which the Notice is posted lies approximately midway between the two sides and is 1090 feet from the EAST end and 10 feet from the WEST end.


