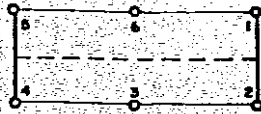
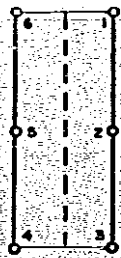

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH 1151 Lode Mining Claim on this 10TH day of FEBRUARY, 19 81, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

(\*) Said Claim is located in the SE (Quarter), Section(s) 35, Township 22 NORTH, Range 51 EAST, Mt. Diablo P. M., and more particularly described as follows, to-wit:

Beginning at the Northeast Corner Post Number 1,

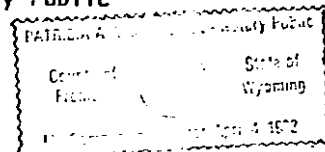
