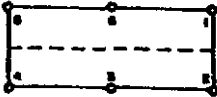
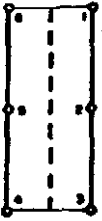

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the NM 1234 Lode Mining Claim on this 7TH day of FEBRUARY, 19 81, situated in the MT. HOPE Mining District, EUREKA County, Nevada.
