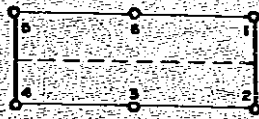
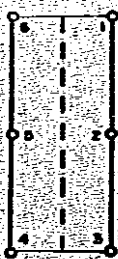

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH 1425 Lode Mining Claim on this 9TH day of FEBRUARY, 19 81, situated in the MT. HOPE Mining District, EUREKA County, Nevada.
