

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Polar No. 2 Lode Mining Claim in Section 6, Township 25 N, Range 53 E in the unknown Mining District, in Eureka County, in the State of Nevada, on the 9th day of March, 1981.

The claim is 1560 feet long and 600 feet wide, and 100 feet is claimed in a North direction and 1400 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Painted markings
