

## CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN

The undersigned hereby certify that they have located the  
AA# 524 Lode Mining Claim in NE 1/4 of Section 29 and  
SE 1/4 of Section 20,  
Township 36 North, Range 50 East, Mount Diablo Base and Meridian, in  
the State of Nevada, on the 10th day of March 1981.

The names and post office address of the locators are

The claim is 1500 feet long and 600 feet wide, and 30 feet  
is claimed in a northerly direction and 1470 feet is claimed in a  
southerly direction from the location monument, at which the Notice  
of Location is posted, lengthwise of the claim, together with 300  
feet in width on each side of the center of the claim. The general  
course of the lode deposit and premises is northerly and southerly.

The location and number of each corner of this claim is shown  
on the claim map that is filed herewith. On the ground each corner  
of the claim is marked with its appropriate symbol with a felt tip  
marker. Each corner is a 4" dia. wooden post.

The claim boundaries are more specifically described as  
follows: beginning at the location monument which is situated  
approximately 10,500 feet northeasterly from the southeast corner of  
Section 31, Township 36 North, Range 50 East, thence southerly  
30 feet to the center of the south end line, point of origin,  
thence westerly 300 feet to a corner post marked "1 of AA 524",  
thence northerly 750 feet to a side center post marked "2 of  
AA 524", thence northerly 750 feet to a corner post marked "3 of  
AA 524", thence easterly 600 feet to a corner post marked "4 of  
AA 524", thence southerly 750 feet to a corner post marked "5 of  
AA 524", thence southerly 750 feet to a corner post marked "6 of  
AA 524", thence westerly 300 feet to the center of the south  
end line, point of origin.

AA 549 on the north, AA \_\_\_\_\_ on the east, AA 525 on  
the south, AA 522 on the west.

The monumentation and marking of the corners was completed by  
the 12th day of March 1981.
