4. FRANCIS A. MOORE has filed herein his Consent to Act as Trustee, and he is a fit and proper person to act in such capacity.

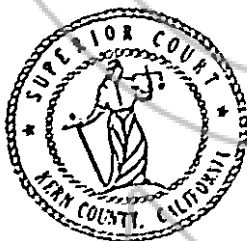
IT IS THEREFORE ORDERED:
