11 have nominated as successor trustee to FRANCIS A. MOORE, JR.,
12 BANK OF AMERICA NATIONAL TRUST AND SAVINGS ASSOCIATION, whose con-
13 sent to so act is on file in this proceeding.

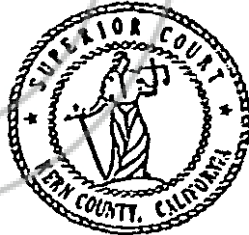
14 IT IS THEREFORE ORDERED:
