MEMORANDUM OF MINING AGREEMENT WITH OPTION TO PURCHASE

NOTICE IS HEREBY GIVEN that MAYNARD BISONI and MARY BISONI, husband and wife, and LESTER A. BISONI and GENEVE BISONI, husband and wife, (therein and hereinafter referred to as "Optionor"), and AMERICAN SELCO INCORPORATED, a New York corporation, (therein and hereinafter referred to as "Optionee"), have entered into a Mining Agreement with Option to Purchase ("Agreement") dated the 1st day of April 1981, with respect to the mining claims described in Exhibit A attached hereto and by this reference made a part hereof and which claims are therein and hereinafter referred to as the "Subject Premises".

Any assignment of interest under the Agreement and this

Memorandum of Agreement shall be made expressly subject to the

Agreement and shall require the assignee to assume and agree in

writing to perform all the obligations of the assignor under the

Agreement as relate to the interest assigned. In case of

assignment by mortgage, however, such assumption of obligations

shall not be required, but should such mortgage be foreclosed,

the purchaser on foreclosure shall take subject to the Agreement.

The provisions of the Agreement and this Memorandum of Agreement

shall inure to the benefit of and be binding upon the parties and
their heirs, executors, administrators, personal representatives,

beneficiaries, successors and assigns. No assignment shall be

effective as between the parties until the first day of the next

month following the delivery to the non-assigning party of

satisfactory evidence of such assignment.


