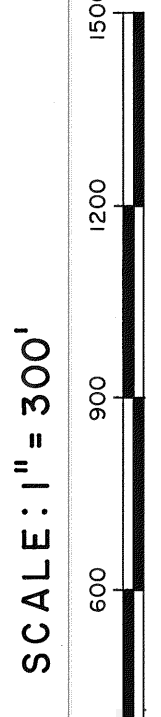

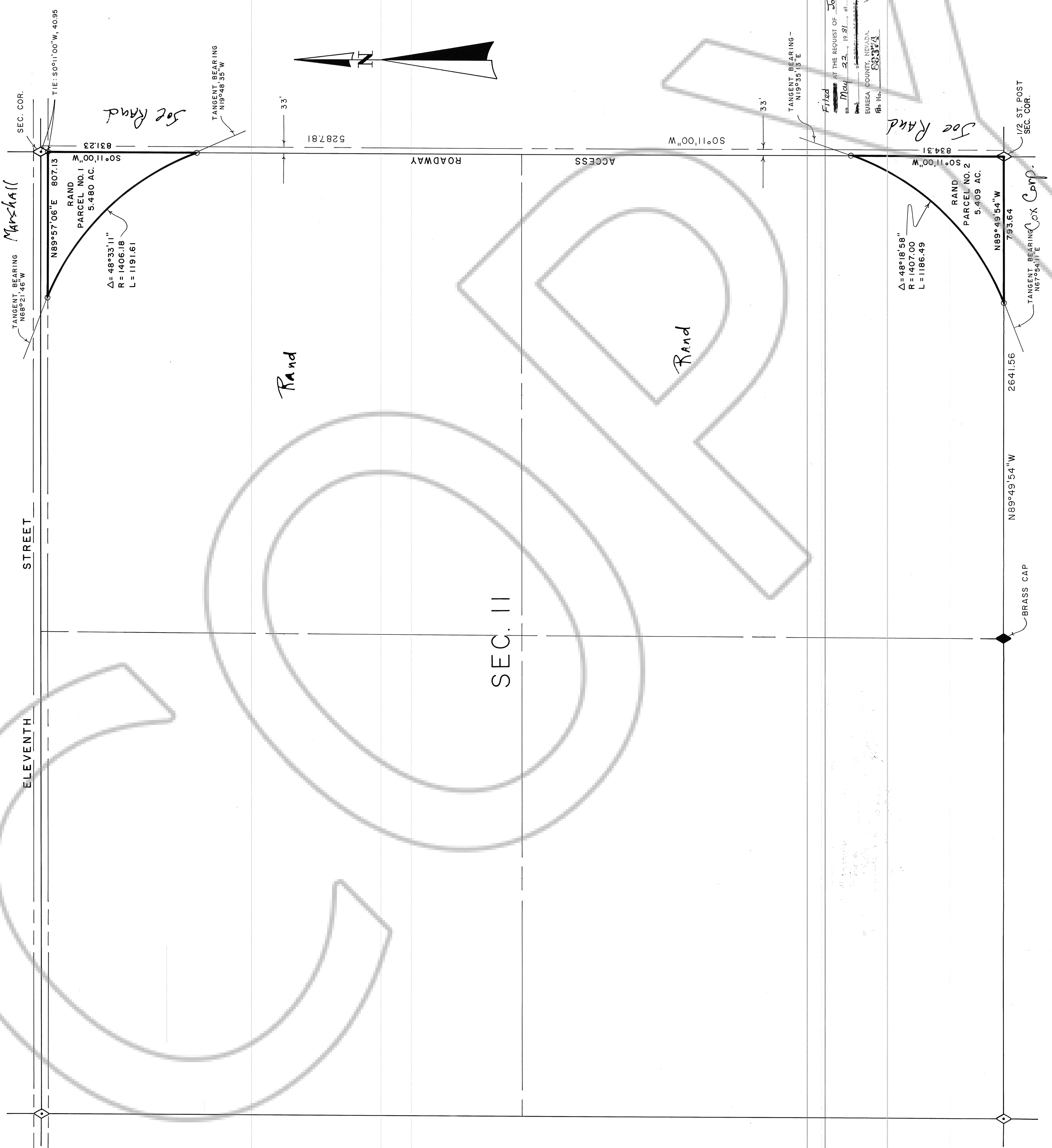


PARCEL MAP
